ABOUT STENNIS SPACE CENTER

John C. Stennis Space Center is a unique federal and commercial city that is home to more than 40 federal, state, academic and private organizations and numerous technology-based companies. For more than five decades, Stennis has served as America's largest rocket engine test complex. Located in Hancock County, Mississippi on the Louisiana border, the center offers a workforce of 5,000 civil servants, contractors, scientists and engineers. The center provides a significant source of employment and income in the two-state region.

MICHOUD ASSEMBLY FACILITY

Michoud Assembly Facility in New Orleans, Louisiana is managed by Marshall Space Flight Center in Alabama. This facility is essential to NASA's human space exploration mission. It is home to one of the world's largest indoor manufacturing facilities, has 900,000 square feet of office space, a deep water port used for transportation, and its own dedicated rail head. Michoud's importance to Louisiana and the Nation goes beyond NASA. Michoud provides a significant source of employment and income in the two-state region. It's multi-tenant facility houses government agencies and private companies that support 3,500 employees on site every day.
